- **Masks and hand gloves of the candidates are mandatory for Physical admission.**
  - **Quarantine rules as per ICMR guidelines to be followed strictly.**
  - **The ArogyoSetu app status of the candidates shall be checked and only such candidates shall be allowed admission who have green status in app or have normal temperature on thermogun and no sign symptom of COVID-19.**
  - **All the colleges shall apply TRUNAT facility in their hospital to test all such arriving candidates for COVID-19 status and the TRUNAT report shall be communicated to them within the same day. If they are found to be negative, they shall be allowed place in hostel and can join duty from the next day itself.**
  - **If the candidates are found to be symptomatic /ArogyoSetu App not being green or TRUNAT result as inconclusive then they shall be undergoing RT PCR and sample to be collected in same college as per COVID-19 protocol and the result shall be provided under priority. They need a stay in Govt. quarantine centre close to the Medical College designated for 1-2 days till the results are received. If the result is negative they can immediately join duty. If the result is positive in TRUNAT/RT PCR then the COVID-19 protocol shall come to vogue and the candidate shall be admitted in COVID-19 facility of the hospital or nearby designated hospital and can only join once declared cured.**
  - **If such candidates who have to stay overnight as TRUNAT are inconclusive, are found to be living in Kolkata (for Kolkata based colleges) then they can stay at their home as home quarantine till the result of RT PCR arrives. If such candidates are found to be in other districts of WB then the candidates have to report to the respective BMOH of their place of residence and remain institutional quarantine and to the RT PCR test in that district and can only join back if such report comes to be negative.**
  - **For colleges other than Kolkata, if the same district candidate has inconclusive report they can stay at home quarantine till RT PCR comes negative. For other state candidate they have to stay in institutional quarantine till RT PCR report comes negative and this institution shall be close to the admitting Medical College and designated Govt. institution. If such candidates are found to be in other districts of WB then the candidates have to report to the respective BMOH of their place of residence and remain institutional quarantine and to the RT PCR test in that district and can only join back if such report comes to be negative.**
